Merton believed that these goals were shared by most of society, but not all people had the opportunity to achieve these success goals. Merton said that there were five ways in which individuals could respond to the success goals in society, which were conformity, ritualism, innovation, retreatism and rebellion.

An individual's response to success goals was often determined by their opportunity to achieve them.
